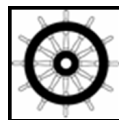

composed of "Ardex K 70" added 1.75 litres "Ardex E 25" per 25 kg "Ardex K 70".

Thickness 7 mm. Density of "Ardex K 70" 1.7 kg/litre. Substrate primed with "Ardex P 82" before application.

Maximum thickness 30 mm.

Weight: 47.6 kg/m<sup>2</sup>.

### **Application/Limitation**

Primary deck covering, not generating excessive quantities of smoke nor toxic products in fire.

The product may also be used as floor covering in accordance with IMO 2010 FTP code part 5 appendix 4 paragraph 4.9.2.

The product may be applied over any steel or non-combustible material.

Approved colour: light grey and brighter colours.

Maximum organic content: approx. 4.7 %.

Not to be used as an integrated part of horizontal class A division unless tested as such.

Each product is to be supplied with its manual for installation and use.
